_____ 1. Prior to participating, I will inspect the launch/tournament area and any equipment to be used, and if I believe anything is unsafe, I will immediately advise an agent or employee of Jaxkayakfishing/Daniel of the existence of such condition(s) and refuse to participate.

_____ 2. I acknowledge and fully understand that I will be engaging in activities that involve risk of damage to personal property, or serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own actions, inactions or negligence, but the actions, inactions or negligence of others, as a result of kayaking, fishing, wading in the water and swimming, including but not limited to perils of sea and waterways, acts of other participants, adverse sea and weather conditions, and I hereby assume complete responsibility and liability for such risks. Further, there may be other risks not known or not reasonably foreseeable at this time.

_____ 3. I do hereby release, waive, discharge and COVENANT NOT TO SUE Jaxkayakfishing/Daniel, its directors, agents, employees, sponsors or any other individual in any way associated with Jaxkayakfishing/Daniel, all of which are hereinafter referred to as "Releasees," from any and all liability to me, my heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence or any other actions of the Releasees or otherwise.

_____ 4. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation.

_____ 5. I certify that my physical condition and training are adequate to enable me to compete safely in this Jaxkayakfishing/Daniel event.
